

**Georgia USAG Board Meeting  
November 20, 2011

**New Levels in 2013**

The board discussed issues that members feel should be addressed. The change in level requirements that will occur in 2013 with the new rules could be addressed through parent awareness and education, perhaps with a letter introducing the new levels to parents before they are implemented in 2013.

## **Scoring Issues**

The perception by some coaches that the gyms are losing gymnasts due to low scores will be addressed at the summer clinic. We will come up with a format or session that will allow coaches and judges to discuss the issue in a non-confrontational manner, with perhaps some positive ways to discuss scores with parents.
